Reports/Recommendations from Contractors/Employees:

- A. Austin Muse MUNICIPAL DISTRICT SERVICES Austin gave his monthly report. He also let Council know that the meter for the water interconnect we have with City of Alvin had to be pulled. Austin said he is working on receiving quotes from engineers to get the interconnect recommissioned, because we could possibly need the water supply in the future during a disaster. Council asked questions regarding the price increases proposed by MDS.
- B. Shohn Davison MARSHAL'S OFFICE Marshal Davison gave his monthly report.
- C. Travis Hobbs EMERGENCY MANAGEMENT COORDINATOR Travis was not able to attend this meeting. Mayor Wilson said that he was putting together a workshop or special meeting to address everyone's roles during a hurricane and for the hurricane season.

Minutes:

Alderwoman Simoneaux and Alderman McGilvray motioned to approve the minutes for the Regular Session Council Meeting April 12, 2021, pending that the Clerk make the requested correction. All approved and the motion carried.

Monthly Financial Statements:

Alderman Franzen and Alderman Mondragon motioned to approve the February 2021 Financial Statements. All approved and the motion carried.

New Business:

- 1) SWEAR IN NEWLY ELECTED OFFICIALS: COUNCIL MEMBERS (SARAH SIMONEAUX, KORY IZARD WROBLISKI, AND RANDY LEE SMITH).

 Mayor Wilson swore in all new Council Members.
- 2) DISCUSSION AND POSSIBLE ACTION ON APPOINTING A NEW MAYOR PRO-TEM. Alderman McGilvray and Alderwoman Simoneaux motioned to appoint Alderman Mondragon as the new Mayor Pro-Tem. All approved and the motion carried.

- 3) DISCUSSION AND POSSIBLE ACTION APPOINTING ALDERMAN RESPONSIBILITIES. Mayor Wilson appointed duties and responsibilities to each Alderperson for the term of their position on Council. See attached.
- 4) DISCUSSION AND POSSIBLE ACTION ON APPOINTING NEW MEMBERS TO THE BUILDING AND STANDARDS COMMISSION. Mayor proposed four new members to our Building and Standards Commission. See attached. The Council asked questions about the Commission. Alderman McGilvray and Alderwoman Simoneaux motioned to approve the four people Mayor Wilson proposed to join our Building and Standards Commission. All approved and the motion carried.
- 5) DISCUSSION AND POSSIBLE ACTION ON THE SECOND AND FINAL READING OF ORDINANCE 34B-2021, AN ORDINANCE CONCERNING RECREATIONAL VEHICLES. Mayor Wilson read this ordinance and pointed out all the changes from the previous version. Council then discussed these changes. Alderwoman Simoneaux motioned to make some changes discussed. No one seconded this motion, so the motion did not carry. Alderman Mondragon and Alderman McGilvray motioned to approve the second and final reading of Ordinance 34B-2021 as is. Alderman Smith, Alderwoman Izard, Alderman Mondragon, and Alderman McGilvray approved the motion. Alderwoman Simoneaux opposed. The motion carried.
- 6) DISCUSSION AND POSSIBLE ACTION ON THE FIRST READING OF ORDINANCE 34A-2021, AN ORDINANCE CONCERNING LITER ABATEMENT.

 Alderman Mondragon and Alderwoman Izard motioned to approve the first reading of Ordinance 34A-2021. All approved and the motion carried.
- 7) DISCUSSION AND POSSIBLE ACTION ON THE FIRST READING OF ORDINANCE 34C-2021, AN ORDINANCE CONCERNING JUNK VEHICLES.

 Alderwoman Simoneaux and Alderwoman Izard motioned to approve the first reading of Ordinance 34C-2021. All approved and the motion carried.
- 8) DISCUSSION AND POSSIBLE ACTION TO SET THE PAY RATE FOR OUR OPERATIONS ADMINISTRATOR.

Alderwoman Simoneaux and Alderman Mondragon motioned to break into Executive Session. All approved and the motion carried. Council discussed what the pay rate should be for our new Operations Administrator. Council then came back into the public meeting.

Council offered John Patterson, Operations Administrator, a flat rate of \$750.00 per month for the remainder of this fiscal year, and this rate will be re-evaluated during the budget process. Alderwoman Simoneaux and Alderwoman Izard motioned to approve this pay rate and asked John if he accepted this offer. John accepted this offer. All approved and the motion carried.

Follow-Up Business:

1) DISCUSSION AND POSSIBLE ACTION ON A NEW BUILDING RENTAL COORDINATOR.

Alderwoman Simoneaux and Alderman McGilvray motioned to remove this topic from the agenda. All approved and the motion carried.

2) DISCUSSION AND POSSIBLE ACTION ON ACCEPTING A NEW INSPECTION SERVICE AGREEMENT.

Alderwoman Simoneaux and Alderman Mondragon motioned to discuss this item after the new members were sworn in. All approved and the motion carried. This topic was discussed earlier in the meeting.

Darron Ray explained his credentials to Council and answered any questions asked by Council. Alderman Mondragon and Alderman McGilvray motioned to accept Darron Ray's proposed Inspection Service Agreement. All approved and the motion carried.
