1) DISCUSSION AND POSSIBLE APPROVAL OF A LETTER OF NO OBJECTION (LONO) FOR PARKSIDE TRAILS LLC TO PROCEED WITH CONSTRUCTION OF THE DEVELOPMENT LOCATED OFF FAIRWAY DRIVE. There have been several meetings regarding figuring this issue out with Fairway Drive. Alderman Mondragon and Alderman McGilvray motion to deny approval of the

Letter of No objection till there has been a meeting with Brazoria County Road and Bridge. All approved and motion carries.

- 2) DISCUSSION AND POSSIBLE APPROVAL OF CITY FUNDS TO BE INVESTED IN MONEY MARKET FUNDS OR CERTIFICATE OF DEPOSITS BY ERIC ANDREAS. Alderman Dawson and McGilvray motioned for Mayor Wilson and Alderman Mondragon to setup a meeting with Lisa Freitag to figure out what amount of funds to move and be able to move the funds. All approved and motion carried.
- 3) DISCUSSION AND POSSIBLE ACTION ON SELECTING A TAX RATE FOR THE NEW FISCAL YEAR 2024. Hillcrest Village has 261 homes. Alderman McGilvray and Randy Smith motion to increase sewer tax rate from \$44.00 to \$47.75 per house for the tax year of 2023-2024.
- 4) DISCUSSSION AND POSSIBLE ACTION ON ELIMINATING THE FIRST CHALLENGE WE FACE WHEN APPLYING FOR GRANT MONEY TO HELP THE CITY. Alderman Dawson wanted an independent audit. Council discussed sending Travis Hobbs to grant writing course (4 days) to continue his work on the grant side.
- 5) DISCUSSION AND POSSIBLE ACTION ON AN INTERLOCAL AGREEMENT BETWEEN BRAZORIA COUNTY ENGINEERING AND HILLCREST VILLAGE. Council discussed that nothing has changed on this agreement. Alderman McGilvray and Alderwoman Izard motion to approve the continued Interlocal agreement. All approve and motion carries.
- 6) DISCUSSION AND POSSIBLE ACTION OF INSTALLATION OF AN EMERGENCY NATURAL GAS GENERATOR TO WELL #2. Alderman McGilvray speaks regarding this topic and Caleb (MDS rep) joins the discussion. \$9,000 would provide one auto dialer onto well to let us know if the water level or pressure is too high or too low, to help keep pump from being dry when they show up. One year phone subscription is included in \$9,000. Alderman McGilvray and Alderman Smith motions to move forward for the bid process on a natural gas generator to well #2. All approved and motion carries.
- 7) DISCUSSION AND POSSIBLE ACTION REGARDING OPERATIONS ADMINSTRATOR'S SALARY. Council asked the public to leave so they could conduct a private executive session.
