- A. Caleb Cristofaro—MUNICIPAL DISTRICT SERVICES Caleb gave his monthly report. Estimate was given for hand dig 70 LF trench, 1 Ft deep and install 1.5" electrical conduit (low voltage) for \$3,000, from blowers to lift station. He stated one hydrant is 50/50 on needing to be replaced. Council asked about water samples and reports.

Alderman Mondragon motion to give permission to Mayor Tom Wilson and Alderman Brad Dawson to move funds from a money market account at PNC Bank to a Certificate of Deposit located at PNC Bank. Alderman McGilvray seconded. Motion carried 5-0, motion approved. Mayor Wilson stated it would be approximately \$180,000 would be moved to a 5% Certificate of Deposit.

Alderman Smith seconded. Motion carried 5-0, motion approved.
