

**Minutes for Special Session Council Meeting
City of Hillcrest Village
Monday, July 29, 2026**

Mayor McGilvray called the Special Session Council Meeting to order at 6:00 pm.

Present: Mayor McGilvray, Alderman Allbright, Alderman Mondragon, Alderman Simoneaux, Alderman Sital.

Pledge

Pledge was completed.

A. FOLLOW-UP BUSINESS

- 1) DISCUSSION AND POSSIBLE ACTION ON THE APPROVAL TML FINANCE BOOT CAMP.
Council reviewed contract with TML for financial training services. Alderman Allbright motioned to approve the TML Financial Boot camp training services contract. Alderman Simoneaux seconded. All approved and the motion carried.
- 2) DISCUSSION AND POSSIBLE ACTION ON COASTAL POWER PRODUCTS LLC. GENERATOR MAINTENANCE CONTRACT.
Mayor McGilvray spoke regarding the updated generator maintenance contract and stated how it was currently delayed maintenance till the new contract is signed. Alderman Allbright motioned to approve the Coast Power Product LLC generator maintenance contract. Alderman Simoneaux seconded. All approved and the motion carried.
- 3) DISCUSSION AND POSSIBLE ACTION ON THE APPROVAL OF THE POLICE RESERVE ORDINANCE.
Council had previously reviewed this ordinance with Chris Duncan. Alderman Allbright motioned to approve police reserve ordinance for the safety and wellbeing of the residents. Alderman Mondragon seconded. All approved and the motion carried.
- 4) DISCUSSION AND POSSIBLE ACTION ON THE APPROVAL OF UPDATED ORDINANCES.
Discussion and review of ordinances with Marshal and Chris Duncan and corrections to be made, no action taken. Marshal suggested warnings for 60 days as they wait for municipal court to be put into place.
- 5) CONVENE INTO EXECUTIVE SESSION 551.074 (PERSONNEL MATTERS) AND 551.071 (CONSULTATION WITH ATTORNEY).
Council convened into Executive Session at 7:16 pm. Marshal was allowed to leave meeting entirely and Secretary was asked to be absent for the executive session.

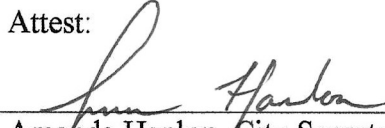
- 6) RECONVENE INTO OPEN SESSION TO DISCUSS RESULTS OF EXECUTIVE SESSION.

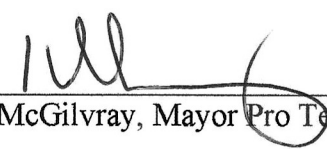
